**What is eScrip?**

eScrip is a hassle-free way for us to raise funds through everyday purchases at registered eScrip merchants. You shop the way you like to shop for groceries, clothing, travel and entertainment. It's simple and convenient, all you need to do is register your grocery club card and debit/credit cards.

**What merchants participate in the program?**

Supporters include Macy's, Safeway, Whole Foods Markets, Zupan's Markets, Dream Dinners, Linens 'n Things, Office Max, American Airlines, Club Cruise, Eddie Bauer, and Shutterfly. There are also a host of online merchants. Full lists are available online at [www.escrip.com](http://www.escrip.com).

**How secure is this program?**

Protecting your personal information is a top priority at eScrip. Their website has security measures in place to protect the loss, misuse and alteration of the information under their control. The transfer of confidential information such as credit card numbers and financial data are communicated via state-of-the-art encryption. eScrip's Web server and database reside behind a firewall in a secure datacenter with fault tolerance, offsite backup and firewall protection. Additionally, EHS Band and Colorguard Boosters will not see any account numbers in the monthly reporting.

**How does money get directed to my student's account?**

Once you register your grocery club card and debit/credit cards with eScrip, you must complete the attached [eScrip Student Account Designation Form](#) and send it to your eScrip Program Coordinator, Colleen Earls, at [ccearls@msn.com](mailto:ccearls@msn.com). Until this form is completed and emailed to Colleen, any money earned will be automatically credited to the general booster fund, no exceptions.

**How do I get started?**

Go to [www.escrip.com](http://www.escrip.com) and click on "sign up." Next, designate our group to receive contributions. Our Group ID # is 500006319. Register your grocery club cards from participating merchants as well as your debit, ATM and credit cards. Then, start shopping. That's it! If you don't have online access, please contact your Program Coordinator for more information.

**Can friends, family or neighbors use this program?**

Absolutely! Every time grandma in Arizona goes to Safeway, she could be earning money for your child! Simply have them follow the same above steps. To ensure the money gets earmarked for your student's account, make sure you complete the eScrip Allocation Form and email that to the Program Coordinator.

**How can I keep track of my student's earnings?**

You can track your student's earnings through the account that you establish online with eScrip. For security purposes you will not have visibility to money earned by friends, family and neighbors on your student's behalf. However, you will be able to see these on your statements from the boosters.

*IMPORTANT NOTE: eScrip charges a 15% administrative fee to participate in the program. Any monies earned, will automatically have 15% deducted to cover this fee.*
